

# COMPETITION RULES & CONDITIONS

## Pass'Portes quizz 2018 «Endura»

### ARTICLE 1:

The AIERM (Association Internationale des Exploitants des Remontées Mécaniques), registered with SIRET number 531 262 566 000 15, headquartered at 1401 route de Vannes – 74390 Châtel, FRANCE, represented by its president, Mr Alain BLAS, is the organiser of a free-to-enter, no-purchase-required competition, hereafter entitled Pass'Portes quizz 2018 "Endura", running from 4th June 2018 until 1st July 2018.

### ARTICLE 2:

The competition is open to all adults excluding all members of the organising company and their relatives. One participant per household (with the same name and postal address).

### ARTICLE 3:

The competition details will appear in the roadbook accompanying the Pass'Portes du Soleil MTB 2018, published by Bike Magazine in June 2018, also at **www.passportesdusoleil.com**, and also during the Pass'Portes Bike Show in Morzine on 29<sup>th</sup>, 30<sup>th</sup> June and 1<sup>st</sup> July 2018. The competition runs from 4th June 2018 at 9am until 1<sup>st</sup> July 2018 at midnight, at which point it will be declared over.

### ARTICLE 4:

To take part, **all questions** must be answered at **www.passportesdusoleil.com** (Bike Show – Prize draw) from 4<sup>th</sup> June 2018 and by 1<sup>st</sup> July 2018 at midnight. Entries will only be processed under the express proviso that all questions are answered. The winner will be chosen at random from all entries received which contain correct answers to all questions.

### ARTICLE 5:

All participants must supply the following personal information to take part in the competition: surname, first name, full postal address, date of birth, telephone number, email address. These fields are **obligatory** and must be completed before entries are processed.

The competition will be declared over on 1<sup>st</sup> July 2018 at midnight, French time; any answers received after midnight as indicated by the time of reception will not be processed.

In the event of a dispute, entries will be deemed to have been submitted by the owner of the email accounts from which they were sent. Entries will be deemed void from anyone not fulfilling the conditions detailed here.
