

Authorisation to resell an entry - Pass'Portes du Soleil MTB 2024

Unfortunately, you can no longer participate to the Pass'Portes du Soleil MTB 2023 and wish to exchange or resell your entry. The event organisers have authorised the resale of tickets, under certain conditions, in order to facilitate the organisation of the event.

Here is the procedure to follow

1. Find a buyer.

We advise you to give your entry to someone you know. However, if you have not found any takers in your circle, you can use the Pass'Portes Facebook group. To post a publication, you must be a member of the "Groupe-Pass'Portes du Soleil MTB" group. Only publications for the resale of entries are validated by the administrator. Requests to buy a ticket will not be published.

2. Complete the attached form and send it by email to the buyer and the organiser: inscription@portesdusoleil.com. Please copy this email to the buyer.

3. Reallocation of the entry to the buyer :

The buyer must create an account on Sports'N Connect if he does not already have one. The organiser will transfer the entry to the buyer's account. The buyer will also be able to access the booking directly. The buyer will also receive a confirmation email.

Conditions :

- **Price:** The holder of a ticket for the 2024 edition may resell it at a similar or lower price than the original rate on the official registration site. **In no case may the resale price be higher than its initial value.**
- **Liability:** The organisers remind you that this type of transaction must remain casual. They do not guarantee the financial transaction and cannot be held responsible in case of dispute.
- **Form:** The form below must be **completed by the original holder of the entry**. In the case of multiple listings, he/she must complete as many authorizations as listings sold.
- **Resale: A place can only be resold once.**
The place is resold as it is. Under no circumstances may the following elements be modified: initial choice of ride, departure, options subscribed.
- **Validity: These changes must remain exceptional and are subject to acceptance by the organisation.**
